SUBJECT: CHARGES RE: AI-17-003

An investigation has been conducted by the Administrative Investigation Division, Professional Standards Bureau, of the Pinellas County Sheriff's Office. As a result of this investigation, the Administrative Review Board has determined you committed the following violation:

While on and off duty in Pinellas County Florida, you violated the Pinellas County Sheriff's Civil Service Act Laws of Florida, 89-404 as amended by Laws of Florida 08-285, Section 6, Subsection 4, by violating the provisions of law or the rules, regulations, and operating procedures of the Office of the Sheriff.

1. You violated Pinellas County Sheriff's Office General Order 3-1.3, Rule and Regulation 3.40, Associating with Married Members.

Synopsis: You were involved in an inappropriate relationship with another agency member, former Sergeant Michael Gibson #56426, who at the time of this relationship, was employed by the Pinellas County Sheriff's Office. At the time of this intimate relationship, Sergeant Michael Gibson was married to another agency member, not separated or residing apart from his spouse and had not legally filed for divorce.

You admitted to this violation.

Disciplinary Points and Recommended Discipline Range:

You were found to be in violation of one (1) Level 3 Rule/Regulation, totaling fifteen (15) points. These points, which were affected by no modified points from previous discipline, resulted in fifteen (15) progressive discipline points. The recommended discipline ranges are from a Reprimand to a three (3) day Suspension.

Disciplinary action shall be consistent with progressive discipline, for cause in accordance with the provisions of the Pinellas County Civil Service Act.
