**SUBJECT:** CHARGES RE: AI 25-004

An investigation has been conducted by the Administrative Investigation Division, Professional Standards Bureau, of the Pinellas County Sheriff's Office. As a result of this investigation, the Administrative Review Board has determined that you committed the following violation:

On, but not limited to, March 6, 2025, while on duty in Pinellas County, Florida, you violated the Pinellas County Sheriff's Civil Service Act Laws of Florida, 89-404 as amended by Laws of Florida 08-285, Section 6, Subsection 4, by violating the provisions of law or the rules, regulations, and operating procedures of the Office of the Sheriff.

1. You violated Pinellas County Sheriff's Office General Order 3-1.1, Rule and Regulation 5.4, Duties and Responsibilities.

Synopsis: On March 6, 2025, while assigned as a deputy on the 2F floor, you opened a secure food port/access hatch and allowed an inmate on Administrative Segregation status to receive, transport, and ultimately destroy suspected contraband items.

You failed to perform a core duty, ensuring the safe and direct transport of the inmate to his assigned cell. This lapse compromised the safety of fellow deputies, inmates, and overall jail operations. Your actions violated established security protocols, which mandate that deputies maintain effective control and supervision over inmate movement within the facility.

During your Administrative Investigation Interview and the Administrative Review Board, you acknowledged you made procedural errors on March 6, 2025. You stated that before the incident, you had interacted with the inmate involved on four (4) separate occasions but failed to review his Close Confinement (CC) housing history. You further admitted that, during transport, you deviated from proper protocol by stopping at a housing pod and opening a food port to allow a second inmate to pass commissary items, specifically, soup, oatmeal, and half a bag of coffee, to the segregated inmate. You confirmed that you had permitted similar exchanges "about a handful" of times in the past.

You also acknowledged that you engaged in a pattern of failing to conduct consistent pat-down searches of inmates entering or exiting housing units. Additionally, you admitted to not reviewing

the Jail Information Management System (JIMS) at the start of your shifts to verify the confinement or segregation status of inmates.

You admitted to the violation.

Disciplinary Points and Recommended Discipline Range:

You were found to be in violation of one (1) Level Five Rule and Regulation violation totaling fifty (50) points. These points, which were affected by zero (0) points from previous discipline, resulted in fifty (50) progressive discipline points. At this point level, the recommended discipline range is from a forty (40) hour Suspension to Termination.

Disciplinary action shall be consistent with progressive discipline, for cause, in accordance with the provisions of the Pinellas County Civil Service Act.
