An investigation has been conducted by the Administrative Investigation Division, Professional Standards Bureau, of the Pinellas County Sheriff's Office. As a result of this investigation, the Administrative Review Board has determined you committed the following violation:

On June 14, 2017, while on duty in Pinellas County, Florida, you violated the Pinellas County Sheriff's Civil Service Act Laws of Florida, 89-404 as amended by Laws of Florida 08-285, Section 6, Subsection 4, by violating the provisions of law or the rules, regulations, and operating procedures of the Office of the Sheriff.

1. You violated Pinellas County Sheriff's Office General Order 3-1.3, Rule and Regulation 3.4(d), Performance of Duty.

While working in a direct supervision housing unit of the Pinellas County Jail, you verbally addressed an uncooperative and disruptive inmate concerning facility expectations and guidelines.

During this verbal exchange with the inmate, you testified the inmate was disrespectful, threatening and you stated, "I just lost my cool." You admitted that during this interaction you removed your duty belt, containing equipment issued by the Pinellas County Sheriff's Office: radio, taser, etc.

You admitted you left the equipment unsecured and accessible to other inmates as the verbal exchange continued, potentially jeopardizing the safety of inmates and staff assigned to the inmate housing area.

You admitted to this violation.

# Disciplinary Points and Recommended Discipline Range:

You were found to be in violation one (1) Level Three Rule/Regulation, totaling fifteen (15) points. This point total, affected by no carryover points from previous discipline, resulted in fifteen (15) progressive discipline points. At this point level, the recommended discipline is a Reprimand to a three (3) days Suspension.

Disciplinary action shall be consistent with progressive discipline, for cause in accordance with the provisions of the Pinellas County Civil Service Act.
